Pursuant to share buyback transactions initiated with the resolution of the Board of Directors of MLP Sağlık Hizmetleri A.Ş. dated May 25, 2022, On December 15, 2022, MPARK shares with TL 10,000 nominal value were repurchased within a price range of TL 77.20 – TL 78.70 (weighted average TL 77.81) per share on Istanbul Stock Exchange by MLP Sağlık Hizmetleri A.Ş.,

As of December 15, 2022, total nominal value of repurchased shares have become TL 6,837,000 which represents 3.2864% of the share capital, following the transactions.
