With the related public disclosures, it was announced that the Head Office had started operations to issue bills with a nominal value of TL 600 million with a term of 102 days, via public offering. It was also stated that the amount of the issuance of bills have been increased to a nominal value of TL 900 million, in the event that the demand for the bills exceeds the public offering amount.

The result of the issuance of TL denominated bills with a nominal value of TL 731,9 million and with a term of 102 days, by the permission of the Capital Markets Board dated 16 July 2018, nr. 29833736-105.02.02-E.7852 is attached.
