## Additional Explanations

Reference: Public disclosures of Türkiye İş Bankası A.Ş. (İşbank) on 04.09.2018 and 06.09.2018.

With the related public disclosures, it was announced that the Head Office had started operations to issue bills with a nominal value of TL 600 million with a term of 172 days and bills with a nominal value of TL 400 million with a term of 298 days, via public offering. It was also stated that the amount of the issuance of bills amounting to TL 1 billion might have been increased to a nominal value of TL 1,5 billion, in the event that the demand for the borrowing instruments exceeds the total public offering amount.

The results of the issuance of TL denominated bills with a nominal value of TL 189,2 million and with a term of 298 days, by the permission of the Capital Markets Board dated 5 September 2018, nr. 29833736-105.02.02-E.9338 is attached.
