Pursuant to a review of the Consolidated Financial Statements for the year 2018 prepared in accordance with the Turkish Financial Reporting Standards, it was resolved to propose to the General Assembly to distribute profit as follows from 747.697.000,00 TL Consolidated Net Profit incurred between 01.01.2018 - 31.12.2018;

- Payment of Gross 472.427.586,85 TL dividend in cash (Gross %40, net %34) to the shareholders who are representing the 1.181.068.967,12 TL capital,

- To reserve the remaining amount as extraordinary reserves,

- In the statutory financials recorded in accordance with the Tax Procedure Law, the loss for the current year in amount of 158.223.869,47 TL has been netted off with the Share Premium,

- In the statutory financials recorded in accordance with the Tax Procedure Law, the dividend shall be distributed in amount of 196.227.508,51 TL from Previous Years' Profit and TL 276.200.078,34 TL from Extraordinary Reserves,

and it was resolved to propose the General Assembly to distribute the cash dividend, beginning from 2 April 2019.
