## Additional Explanations

Reference: Public disclosures of Türkiye İş Bankası A.Ş. (İşbank) on 01.06.2020 and 04.06.2020. With the related public disclosures, it was announced that the Head Office had started operations to issue bills with a nominal value of TL 400 million with a term of 116 days and bills with a nominal value of TL 400 million with a term of 116 days, via public offering. It was

also stated that the amount of the issuance of bills amounting to TL 800 million might have been increased to a nominal value of TL 1,2 billion, in the event that the demand for the borrowing instruments exceeds the total public offering amount. The results of the issuance of TL denominated bills with a nominal value of TL 162,5 million and with a term of 249 days, by the permission of the Capital Markets Board dated 3 June 2020, nr. 29833736-105.02.02-E.5555 is attached. This is the translation of the Turkish public disclosure made by Türkiye İş Bankası A.Ş. through the Public Disclosure Platform, under the Material Events Guideline prepared in accordance with the Communiqué of Material Events, numbered II-15.1. According to the Material Events Guideline and the regulations, the Turkish public disclosure shall prevail.
