It was announced by reference disclosure that, with the Bank's Board of Directors' decision, it was decided in order to protect the value of our shareholder's investments and to support the price stability of share's value; to buy back VakıfBank Group D shares up to TL 100,000,000 nominal with a maximum TL 500,000,000 within the scope of Capital Markets Board's Communique on Buyback Shares.

In this context, buyback transactions amounting in total 3,500,000 Group D shares with a price range of TL 3,34 – TL 3,35 which was made today are included at the table.

According to CMB legislation, in case of a contradiction between the Turkish and English versions of this public disclosure, the Turkish version shall prevail.
