Due to the acquisition of 22,334,359,180.5 shares, each with a nominal value of TL 0.01, corresponding to 90.38% of the paid-in capital and voting rights of Mondi Olmuksan Kağıt ve Ambalaj Sanayi A.Ş. (Olmuksan), the management and control of Olmuksan passed to Mondi Corrugated B.V. (Mondi).
