The share buy-back transactions executed on 15.02.2023 based on the resolution of Board of Directors dated on 31.12.2021 and revised dated on 09.01.2024 are added to the table.

On 09.01.2024, 13,178 shares were bought-back from the price range of TRY 47.46 – 48.88 and the number of NATEN shares owned by our Company reached to 393,178. (The ratio to the company capital is 0.238%)

As of 09.01.2024 total shares which bought-back in accordance with the share buy-back programme are 9,558,178.
