Our bank has signed a syndicated loan agreement in the amount of EUR 605 million and USD 276 million with a maturity of 367 days. The all-in cost for the highest participation level of each tranche is Libor+2,75% and Euribor+2,65%. The proceeds of the facility will be used for trade finance purposes.
