Our Bank has signed a syndicated loan agreement in the amount of EUR 545 million and USD 215 million with a maturity of 367 days. The all-in cost for the highest participation level of each tranche is Euribor+2.10% and Libor+2.25%, respectively. The proceeds of the facility will be used for trade finance purposes.
