At this point, with the coordination of Turkiye Wealth Fund it has been decided to change the shareholder and capital structure of the company. In this context, the process of share transfers to Turkiye Wealth Fund has started and the process with PTT A.Ş. will begin following the necessary approvals from the authorities are taken.
