According to TAV Airports' dividend policy, "except for such special cases necessitated by investments and any other fund requirements that may be required for the long term development of the Company, 50% of the "consolidated net profit for the relevant period" calculated by considering the period financial statements that have been prepared under the Capital Market legislation and in conformity with the International Financial Reporting Standards (IFRS) is distributed in cash or as gratis shares."

Because there are sizeable projects that our Company is preparing for, the distribution of a dividend of TRY 392,491,240 which corresponds to TRY 1.0804059 gross dividend per share to commence on March 25, 2020, was approved by the General Assembly.
