Pursuant to our Material Event Disclosure dated December 13, 2019, share purchase agreements were signed between VakifBank as seller and TVF Finansal Yatırımlar AŞ ("TVF Finansal Yatırımlar"), as purchaser on April 22, 2020, for the transfer of the shares we hold in Vakıf Emeklilik ve Hayat AŞ representing 53.9% of its share capital to TVF Finansal Yatırımlar. the transfer of the shares of Vakıf Emeklilik ve Hayat AŞ were completed. Following the share transfer process VakıfBank has no share left in Vakıf Emeklilik ve Hayat AŞ ownership structure.
