As a result of the evaluation of our Company's Articles of Association and Dividend Distribution Policy; our Company's Board of Directors has taken the decision to submit the distribution of our Company's dividend in a gross amount of TRY 2,585,787,148 equivalent of a gross dividend of TRY 1.1753578 (net TRY 0.9990541) per ordinary share with a nominal value of TRY 1 to the shareholders within the scope of the principles set forth in the legislation and in 3 equal instalments for the cash dividend as of 30 April 2021, 30 July 2021, 27 October 2021, to the approval of the Ordinary General Assembly of Shareholders for fiscal year 2020, according to the dividend distribution table which has been prepared for the related fiscal years.

Note: The gross cash dividend per ordinary share with a nominal value of TRY 1 in each installment will exactly be TRY 1.1753578 (net TRY 0.9990541). However, this cannot be stated as such in the above tables which are part of Public Disclosure Platform disclosure due to technical reasons.
